In 4 steps

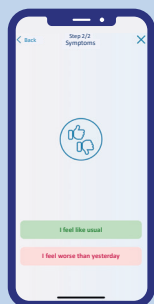


- a. Sit down and place the cuff around your **left arm**.
- b. The **red band** should be placed inside the **crease of your elbow**.
- c. Place your **left arm on a table**, with the **palm facing up**.

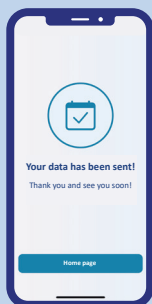

Your data is monitored by your Newcard nurse and your cardiologist.



OUR ADVICE

- Make sure the batteries are inserted in both the scale and the blood pressure monitor.
- To take your blood pressure, sit comfortably in a calm room.
- Place the cuff on your arm, at the same level as your heart.
- The red mark should be in the crook of your elbow.

For the first measure, don't hesitate to ask your relatives, your caregiver, or your neighbour.

YOUR THERAPEUTIC SUPPORT

One mandatory session of approximately 15 minutes by phone, with additional sessions available for:

- **Getting to know your condition better**
- **Learning the appropriate behaviors during your remote monitoring,**
- **Getting involved in your care journey.**
